- Entrance to Clean Room the EXIT sign is not remaining lit during test procedures <u>ACTION</u>: Shannon to submit a Maintenance Requisition – DONE
- Machine Shop exit sign will not work properly if there is a power outage <u>ACTION</u>: Shannon to submit a Maintenance Requisition – DONE
- Machine Shop dust cover strings are broken on the eyewash station and it is not spraying evenly through both spouts- Shannon to go over and inspect to get further information as well as send Maintenance Requisition – Shannon has submitted a Maintenance Requisition - full inspection of facility to be completed

TBRHSC LOCATION:

- 3rd Floor office space (inside 3116)
 - All areas good temperature does seem to fluctuate to very cool at times; will continue to monitor November 13/18 – temperature continues to fluctuate throughout each day and can be very cool at times
- 3rd Floor Lab All Benches
 - The valves that are at each bench contain both a side for VACUUM and a side for GAS which have handles that have been noted to move open easily when any object is placed against or a cord is tangled around; this could potentially cause gas to leak and at an unknown time, could be substantial – <u>ACTION:</u> Shannon to investigate some type of cover/lock-out that could prevent the valves from being accidentally opened – ONGOING

- 3rd Floor Student offices
 - The cords under all desks require some organizing and bundling to prevent tangling of feet and/or tripping – <u>ACTION</u>: Shannon to complete

 - The main entrance door is continuing not to function after-hours it is not opening after cards are swiped and then continues to stay open when it should automatically lock – <u>ACTION</u>: Shannon to submit an additional Maintenance Requisition
